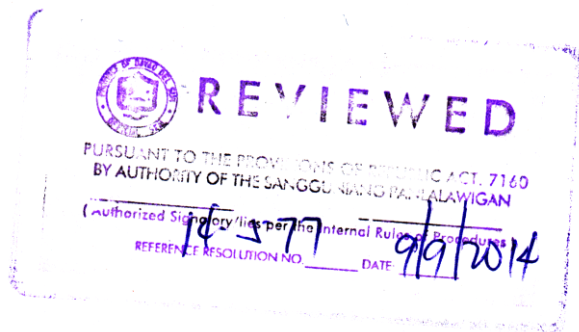
Whereas, after a thorough review, the PLUC members find the document in order and that the comments are substantially considered;

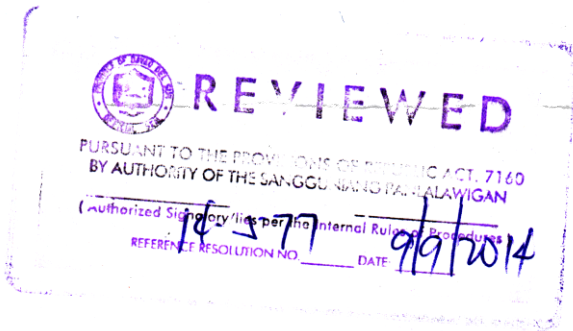


