**EXECUTIVE ORDER NO. 05
Series of 2022**

**AN ORDER ADOPTING THE PROVINCIAL ORDINANCE NO. 21-124
AN ORDINANCE IMPOSING A MODIFIED CURFEW HOURS DUE TO THE
OUTBREAK OF NOVEL CORONA VIRUS (COVID-19)**

WHEREAS, Section 16 of the Local Government Code of 1991 provides that the local government units shall exercise the powers expressly granted, those necessarily implied therefrom, as well as effective governance, and those which are essential to the promotion of the general welfare, including the promotion of health and safety of the people;

WHEREAS, on November 11, 2021, President Rodrigo Duterte issued Executive Order No. 151, Series of 2021 mandating the implementation of the Alert Level System of the IATF in all areas of the country;

WHEREAS, on January 13, 2022, the IATF issued Resolution No. 157-A placing the entire Province of Davao del Sur under Alert Level 3;

WHEREAS, the continued vigilance, formulation and implementation of local issuances on COVID-19 and other proactive measures are necessary to slow down the surge of cases and limit, if not stop, further spread of COVID-19 variants in the municipality of Hagonoy, Davao del Sur;

NOW, THEREFORE, I, FRANCO MAGNO CALIDA, Municipal Mayor of Hagonoy, Davao del Sur, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. TITLE- Modified Curfew Ordinance

SECTION 2. COVERAGE- This order shall cover all persons and all establishments, public and private, within the territorial jurisdiction of the municipality of Hagonoy, Davao del Sur.

SECTION 3. IMPOSITION OF CURFEW- A curfew is hereby imposed upon all persons and all establishments, private and public, based on the IATF Resolutions on placing regions, provinces, municipalities and cities under alert levels, to wit:

ALERT LEVEL	SPECIFIED CURFEW HOURS
1 AND 2	10:00 o'clock in the evening until 4:00 o'clock in the morning
3,4 AND 5	9:00 o'clock in the evening until 4:00 o'clock in the morning

SECTION 4. CLOSURE OF ESTABLISHMENTS- Upon the effectivity of this Ordinance, all establishments within the territorial jurisdiction of the municipality of Hagonoy, Davao del Sur shall strictly observe the specified curfew hours in corresponding alert levels.

The following are not subject to hours of closure herein provided:

1. Foodshops, except restaurants, pubs and bars within the municipality of Hagonoy, Davao del Sur serving alcoholic and/or allowing videoke/karaoke.
2. Grocery Stores
3. Pharmacies
4. Clinics


All employees serving until the prescribed curfew hours are given one-hour allowance for them to go home. Employers are required to give their employees with certifications that they serve on those hours.

SECTION 5. SEPARABILITY CLAUSE. If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 6. REPEALING CLAUSE. All orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

SECTION 5. EFFECTIVITY. This order shall take effect upon its approval until the State of National Public Health Emergency is lifted.
