**EXECUTIVE ORDER NO.18
Series of 2022**

**AN ODER OF PROVIDING GUIDELINES IN SECURING THE
REQUISITE PERMIT IN THE CONDUCT OF ELECTION CAMPAIGN
ACTIVITIES IN THE MUNICIPALITY OF HAGONOY, DAVAO DEL SUR
UNTIL MAY 8, 2022 , IN CONNECTION WITH THE NATIONAL AND
LOCAL ELECTIONS**

Whereas, the World Health Organization (WHO) has declared a Corona Virus Disease (COVID-19) pandemic;

Whereas, President Rodrigo Duterte issued Presidential Proclamation 1021, extending the State of Calamity in the country until September 12, 2022;

Whereas, the Inter-Agency Task Force (IATF) Resolution No.164-D, series of 2022, March 15, 2022, placed Hagonoy, Davao Del Sur under Alert Level 2 effective March 16, 2022 until March 31, 2022;

Whereas, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

Whereas, Commission on Elections Resolution No.10732, Series of 2021, dated November 4, 2021, outlined the guidelines on the conduct of : (1) In person campaign, (2) Rallies, (3) Caucuses, Meetings, and Conventions,(4) Motorcades and Caravans, and (5) Miting de Avance under the New Normal, in connection with the May 9, 2022 National and Local Elections;

Whereas, in consideration of the foregoing and further promoting the security, health, economic and social welfare of every Hagonoyan ;

NOW THEREFORE, I, FRANCO MAGNO CALIDA, Mayor, Hagonoy, Davao Del Sur, by virtue of the powers vested in me by law, do hereby order the following:

Section 1. Adoption. Commission on Elections (COMELEC) Resolution No.10732, Series of 2021 is partially adopted.

Section 2. Exception. Section 16 of COMELEC Resolution No.10732, S.2021, shall not be implemented in the Municipality. All political caravans and motorcades are prohibited due to high price of fuel which adds burden to the public due to economic losses from the pandemic and higher prices of basic commodities;


Section 3. Conduct of Political Activities. No election campaign activity under COMELEC Resolution No.10732, S.2021 shall be conducted without securing a permit from the LGU and coordinated with the Municipal COMELEC Campaign Committee.

Section 4. Penalties. Any violation of the foregoing provisions shall constitute non-cooperation of the persons, entities, and is punishable under existing laws, ordinances, rules and regulations.

Section 5. Separability Clause. If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

Section 7. Repealing Clause. All orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

Section 8. Effectivity. This order shall take effect immediately. Done this 24th day of March 2022 in Hagonoy, Davao del Sur.
