**AN EXECUTIVE ORDER CREATING AND CONSTITUTING THE MUNICIPAL TECHNICAL COMMITTEE ON ORGANIC AGRICULTURE PROGRAM OF THE LOCAL GOVERNMENT UNIT OF HAGONUY, DAVAO DEL SUR.**

**WHEREAS**, pursuant to **RA 10068** otherwise known as **Organic Agriculture Act of 2010**, the Municipality adheres to the policy of the state to promote, propagate, develop further and implement the practice of organic agriculture in the Philippines that will *cumulatively condition and enrich the fertility of the soil, increase farm productivity, reduce pollution and destruction of the environment, prevent the depletion of natural resources, Further protect the health of Farmers, consumers and the general public and save on important farm inputs.*

**WHEREAS**, in promoting the agriculture sector of the municipality. It shall be in accord with the constitutional mandate that "the state shall protect and advance the right of the people to a balanced and healthy ecology in consonance with the rhythm and harmony of nature.

**WHEREAS**, consistent with the declared policy of Republic Act 10068, the government shall make an effort to propagate and develop organic farming method and it is imperative to create a technical committee in the municipal level that shall ensure farm productivity.

**WHEREAS**, Section 14 of **RA 10068** states that "every municipal mayor shall likewise, in so far as practicable, form a municipal technical committee for purposes of implementing activities in line with the National Organic Agricultural Program within each municipality".

**WHEREAS**, the organization of a technical committee on organic agricultural program is vital of the success of the municipality in its desire to advocate, develop and promote organic farming.

**NOW THEREFORE**, by virtue of the power vested in me by the **Republic Act 7160**, otherwise known as the Local Government Code in the Philippines and pursuant to **Republic Act 10068** and its Implementing Rules and Regulations. I, **FRANCO MAGNO CALIDA**, Municipal Mayor of Hagonoy, Davao del Sur, hereby create and constitute the **MUNICIPAL TECHNICAL COMMITTEE ON ORGANIC AGRICULTURE PROGRAM** of the Local Government Unit of Hagonoy, Davao del Sur.

## Section 2. DUTIES AND FUNCTIONS

1. Shall prepare / formulate review, consolidate and endorse Local Organic Agriculture plans, programs, projects and activities of the LGU to the National Organic Agriculture Board (NOAB).
2. Coordinate and consolidate all efforts of different National Government Agencies (NGA's) including its Line Agencies, local government units in the municipality and other stakeholders who are mandated to implement and / or advocate of organic agriculture.
3. Initiate extensive TLC in different levels comprehensively promote the use and benefit of organic agriculture.
4. Shall be the front liners in the implementation of the program related to Republic Act 10068 and shall facilitate the member of municipal ordinance and / or resolutions relative to Local organic and.
5. Shall conduct monitoring of the projects implemented to the LGU including the conduct of Civil Society assembly and submit reports regularly in accordance with policy guidelines and procedures.

## Section 3: EFFECTIVITY

This order shall take effect immediately.
