"AN ORDER CREATING THE EXECUTIVE COMMITTEE AND SUB COMMITTEES OF THE OATH TAKING CEREMONY OF NEWLY-ELECTED AND RE-ELECTED MUNICIPAL OFFICIALS ON JUNE 30, 2022"

WHEREAS, Republic Act No. 7166 An Act providing for synchronized national and local elections and for electoral reforms, authorizing appropriations therefor, and for other purposes;

WHEREAS, the State to synchronize elections so that there shall be simultaneous regular elections for national and local officials once every three (3) years.

WHEREAS, the winning candidates of the May 9, 2022 national and local elections will take their Oath of Office on June 30, 2022 at 12:00 noon and immediately assume office;

WHEREAS, in order to properly plan, execute and ensure the success of this event there is a need create a committee who will facilitate during the said even;

NOW, THEREFORE, I, FRANCO MAGNO CALIDA, Municipal Mayor of Hagonoy, Davao del Sur, by virtue of the powers vested in me by law do hereby order the following:

SECTION 1. CREATION AND COMPOSITION OF THE EXECUTIVE COMMITTEE. The OATH TAKING CEREMONY EXECUTIVE COMMITTEE is hereby created and shall compose of the following persons:

Chairperson: Hon. Franco Magno Calida - Municipal Mayor
Vice-Chairperson: Mr. Dennis S. Lasat, III - ICO, MPDC
Co-Chairperson: Mrs. Agnes C. Labadan - AO IV/HRMO Designate

The members of the Execom are hereby directed to name their respective permanent alternative representatives who shall take their place in case of their absence.

SECTION 2. FUNCTIONS OF THE EXECUTIVE COMMITTEE. - The Execom shall perform the following functions, to wit:

1. Plan and ensure the smooth coordination of programs, events and activities in connection with the event;
2. Invite and/or call for a meeting of the members of the committee;
3. Perform such other act that are necessary to effectively and meaningfully carry out its mandated functions.
