**EXECUTIVE ORDER NO. 28**

**CREATION OF MUNICIPAL INTEGRATED WATER, SANITATION AND HYGIENE  
(iWASH) COUNCIL AND iWASH TEAM**

**WHEREAS**, the Section 17 of RA 7160 or the “Local Government Code of 1991” indicates that Local Government units shall endeavor to be self- reliant and exercise its powers to efficiently and effectively deliver the provision of the basic services and facilities in its area of jurisdiction.

**WHEREAS**, the Section 106 of the Local Government Code of 1991 states that the LGU shall have a comprehensive multi- sectoral development plan.

**WHEREAS**, the Section 109 of the Local Government Code of 1991 states that the LGU shall formulate long- term, medium- term, and annual socioeconomic development plans and policies;

**WHEREAS**, pursuant to DILG memorandum Circular No. 2017-84, LGUs shall align the plan to the National Government’s Philippine Development Plan (PDP) 2017-2022, anchored on a national long- term vision more popularly known as Ambisyon Natin 2040 and country’s international commitment the Sustainable Development Goals (SDGs);

**WHEREAS**, the Goal No. 6 of the Sustainable Development Goal (SDG) is to ensure the availability and sustainable management of water and sanitation for all.

**WHEREAS**, the inclusion of Municipal Integrated Water, Sanitation and Hygiene (iWASH) Council to the Municipality’s Local Development Council (LDC) shall ensure in setting the direction of sustainable water and sanitation for all.

**WHEREAS**, the Municipality shall organize an iWASH Council and Team responsible in establishing the goal, vision, and strategies for local water, sanitation and hygiene sector and for managing and ensuring the efficient and effective implementation of the Program.

**NOW THEREFORE, I, FRANCO MAGNO CALIDA**, Municipal Mayor of Hagonoy, Davao del Sur, by virtue of the power vested in me by law, do hereby order: the reorganization of the Municipal Water and Sanitation (WATSAN) Team and Council into a Municipal Integrated Water, Sanitation and Hygiene (iWASH) Council and iWASH Team to be composed of the following determining each membership functions and responsibilities as follows:

**iWASH Council:**

Chairperson:	Franco Magno Calida, Local Chief Executive
Vice Chairperson:	Roderick R. Vilan, District I Supervisor, DepEd Hagonoy

7. Assist the iBWSA to set up systems, procedures and by laws that would ensure sustained O & M of the iWASH facilities and make available mechanisms for community consultations, reporting and feed- backing.
8. Regularly monitor and assess the performance of Water Service Providers (WSP) (e.g. iBWASAs) to ensure the delivery of adequate, affordable, quality and continuous services on safe water, sanitation and hygiene.
9. Promote mutual accountability between the Water Service Providers (WSP) and water users through development of social contract known as the Localized Customer Codes (LSCs).
10. Ensure the effective and sustainable implementation and delivery of water and sanitation services through their established and institutionalized monitoring system.
11. Facilitate the recognition of newly formed Water Service Provider (e.g. iBWSA, Cooperative, private-owned, et. Al) thru SB Resolution.

**SECTION 3. ADMINISTRATIVE AND OPERATIONAL SUPPORT.**

Upon the effectivity of this order, the Municipal Integrated Water, Sanitation and Hygiene (iWASH) Council and IWASH Team may draw its administrative, operational and budgetary requirements from the available fund of the General Fund/MOOE- Mayor's Office.

**SECTION 4. EFFECTIVITY.** The order shall take effect immediately.
