AMENDING EXECUTIVE ORDER NO. 27, SERIES OF 2020 : REORGANIZING THE MUNICIPAL SCHOOL BOARD OF HAGONOY, DAVAO DEL SUR

WHEREAS, Section 98 of Republic Act No. 7160, otherwise known as the local Government Code of 11 provides that there shall be established in every province, city or municipality a provincial, city or municipal School Board, respectively;

WHEREAS, in order to provide the Municipal School Board with organizational capability to respond to school related issues and concerns; the Municipal school Board is hereby reorganized;

NOW THEREFORE, I , FRANCO MAGNO CALIDA , Municipal Mayor of Hagonoy, Davao del Sur, by virtue of the power vested in me by law, do hereby order:

SECTION 1. Reorganization of Municipal School Board. There shall be a reorganized Municipal School Board to be composed of the Following:

SECTION II. FUNCTIONS. The Municipal School Board shall be responsible to the following:

- a) Determine, in accordance with the criteria set by the DepEd the annual supplementary and budgetary needs for the operation and maintenance of public schools within the Municipality;
- b) Authorize the Municipal Treasurer, as the case may be, to disburse funds from SEF pursuant to the budget prepared and in accordance with the existing rules and regulations;
- c) Serve as an advisory committee to the Sanggunian on educational matters such as but not limited to the necessity and the uses of local appropriations for education purposes;
- d) Recommend changes in the names of public schools within the territorial jurisdiction of Local Government Unit for enactment by the Sangguniang Bayan.

SECTION III. Meetings and budgetary support:

a. Meeting

The Municipal School Board shall meet at least once a month.


b. Budgetary Support

The programs, projects and activities of the Board shall be funded with a budget appropriated for the Local School Board from SEF.

SECTION IV. Repealing Clause. All previous orders inconsistent herewith are hereby repealed accordingly.

SECTION V. Effectivity. This order shall take effect immediately.
