**EXECUTIVE ORDER NO. 05**

**Series of 2021**

**AN ORDER CREATING AND CONSTITUTING THE HAGONUY CHAPLAINCY SERVICE OFFICE (HCSO), AND FOR OTHER PURPOSES**

**WHEREAS**, Article II, Section 21 of the Philippine Constitution which declares that the State shall maintain honesty, integrity in the public service and take positive measures against graft and corruption;

**WHEREAS**, Proclamation No. 62 dated September 30, 1992 declared a Moral Recovery Program in response to the need to strengthen the moral resources of the Filipino people rooted in Filipino culture, values and ideals that are pro God, pro people, pro country and pro nature;

**WHEREAS**, the same proclamation has declared the Moral Recovery Program as official government policy and enjoined the active participation of all sectors in Filipino Society;

**WHEREAS**, Executive Order No. 319 series of 1996 enjoined all government departments, offices agencies, instrumentalities and government-owned and controlled corporations to establish Integrity Circles or any similar mechanism to lay the necessary foundations of the moral recovery crusade for Filipino core value infusion into the organization's culture, system and processes;

**NOW THEREFORE, I FRANCO MAGNO CALIDA**, by virtue of the powers vested upon me as Local Chief Executive of the Local Government Unit of Hagonoy, do hereby order the creation of the Hagonoy Chaplaincy Service Office (HCSO), and for other purposes, designate its members and define its duties and functions, as follows:

**SECTION 1. COMPOSITION.** The Hagonoy Chaplaincy Service Office (HCSO) is hereby constituted as follows:

**SECTION 2. GENERAL FUNCTIONS.** The general functions are enumerated as follows:

1. Conduct activities and programs such as but not limited to:
  - a. Filipino Core Values Integration Training
  - b. Moral Recovery Seminar
  - c. Values Enhancement Seminar
  - d. Regular Moral Renewal Program
  - e. Spiritual Upliftment
2. Appoint a chaplain which shall strictly follow the qualifications and requirements laid down in the Municipal Chaplain Moral Recovery Program;
3. Monitor and supervise the activities and programs implemented by the Municipal Chaplain which shall be in accordance with the Goals of the chaplaincy.

4. Perform such other functions as may be determined by the Hagonoy Chaplaincy Service Office.

**SECTION 3. FUNDING.** All expenses to support the activities of the Hagonoy Chaplaincy Service Office shall be taken from the funding of the Local Government of Hagonoy.

**SECTION 4. SEPARABILITY.** If for any reason, any part or provision of this Executive Order shall be found unconstitutional or invalid, other parts or provisions thereof which are not affected thereby shall continue to be in full force and effect.

**SECTION 5. EFFECTIVITY.** This order shall take effect immediately and shall remain in force until expressly revoked.
