**DESIGNATING THE PARKING AREA FOR TRICYCLES, SINGLE MOTORCYCLES AND PRIVATE VEHICLES**

**WHEREAS**, in line with the DILG Memorandum Circular 2020-145, issued on October 28, 2020 which provides the Road Clearing by all Local Government Units;

**WHEREAS**, the memorandum directed that the local officials are encouraged to develop and implement strategies that will address the displacement issues caused by the implementation of such President's directives;

**WHEREAS**, the Department of the Interior and Local Government Secretary Eduardo Año formalized the order thru the issuance of DILG Memorandum Circular No. 2019-121 to all provincial governors, city and municipal mayors, barangay chiefs, heads of local sanggunians, to cause the implementation of the order;

**WHEREAS**, the Local Government Code of 1991 further provides that the Local Chief Executive shall exercise general supervision and control over all programs, projects, services and activities to ensure efficient, effective and economic governance and for the general welfare of the Local Government Unit and its inhabitants;

**WHEREAS**, the Municipal Government of Hagonoy had started the road clearing which included the temporary parking area adjacent to the national highway and immediately conduct the embankment of the designated parking area;

**WHEREAS**, due to the absence of Municipal Parking Area, there is a necessity to designate parking space in strategic places for the convenience of the travelling public and likewise, for generating family income of the drivers / operators of the tricycles and single motorcycles;

**WHEREAS**, necessitates also the participation and involvement of the private sector, stakeholders / community, the Civil Society Organizations (CSOs) to adopt this management approach that is holistic, comprehensive, integrated and proactive towards the upliftment of the socio-economic living condition of the transport sector and the whole locality, as a whole;

**WHEREAS**, the designated one way parking (right lane) area is at the circumferential road of the municipality, and designated parking space for private owned vehicles by the LGU Employees at their respective offices;

**WHEREAS**, the LGU as the possessor of the place, will maintain and manage the designated parking space and assigned a traffic enforcer/police auxiliary to facilitate the flow of traffic;

**WHEREAS**, the orderliness, safety and systematic manner in carrying passengers will be the responsibility of the Tricycles, Single Motorcycles and Private Vehicles;

**NOW, THEREFORE, I, FRANCO M. CALIDA**, Municipal Mayor of Hagonoy, Davao del Sur, by virtue of the power vested in me, do hereby order shall take effect immediately;
