**EXECUTIVE ORDER NO. 14 S. 2021**

**CREATING/ORGANIZING THE TECHNICAL WORKING GROUP AND SECRETARIAT FOR THE PREPARATION/IMPLEMENTATION OF THE COMMUNITY-BASED MONITORING SYSTEM (CBMS) PROJECT OF MUNICIPALITY OF HAGONUY, DAVAO DEL SUR.**

**WHEREAS**, the Local Government Code of 1991 known as Republic Act No. 7160 provides the Local Government Units assume the primary responsibility for the provisions of the basic services and facilities, the improvement of the quality of life of their constituents, and serve the frontline institutions towards the achievement of the Sustainable Development Goals (SDGs) and addressing poverty at the local level;

**WHEREAS**, the Department of the Interior and Local Government is the office with primary responsibility of localizing the SDGs and capacitating the LGUs on poverty monitoring and planning using the core local poverty indicators, which incorporated the Community-Based Monitoring System (CBMS), as its generation module for poverty-based line data and SDG benchmarks;

**WHEREAS**, the progressive realization of the SDGs is anchored on the contributions of the Local Government Units as well as the non-government and private sectors;

**WHEREAS**, the CBMS is being adopted by the DILG as one of the strategies to localize the SDGs;

**WHEREAS**, the CBMS will be integrated into all Local Development Plans of the Municipality which serves as a vital document necessary in the realization of the Municipality's development thrust;

**NOW THEREFORE, I FRANCO MAGNO CALIDA**, Municipal Mayor of Hagonoy, Davao del Sur by virtue of the powers vested in me by law, do hereby create and organize the Community-Based Monitoring System Technical Working Group.
