EXECUTIVE ORDER NO. 21, S. 2020

PROVIDING ADDITIONAL GUIDELINES FOR THE EXTENDED ENHANCED COMMUNITY QUARANTINE

WHEREAS, follow the guidelines on the Executive Order No. 20, series of 2020 which was issued for the extended Enhance Community Quarantine (ECQ) per Davao Regional COVID-19 Task Force agreement until 11:59PM of April 26, 2020;

WHEREAS, to reiterate the stringent social / physical distancing and STAY AT HOME POLICY;

NOW, THEREFORE, I, FRANCO MAGNO CALIDA, Municipal Mayor of the Municipality of Hagonoy , Davao del Sur by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. APPLICABILITY OF EXECUTIVE ORDER NOS. 17-A and 20, S. 2020. Implement and follow the guidelines of E.O. 17 –A and 20, s.2020 (ECQ Guidelines).

SECTION 2. BORDER CONTROL. Suspension of private and public transportation for inter-LGU travels. All private vehicles and any mode of public transportation shall be prohibited from crossing LGU borders within Davao del Sur **EXCEPT**:

1. For transport vehicles of COVID -19 frontline workers / government personnel and skeletal workforces of establishments that are allowed to operate during the ECQ period. No mass transport of individuals shall be allowed.
2. Residents of Hagonoy who plan to come home to their residences when the ECQ will be lifted.
3. Cargoes/supply deliveries.
4. For emergencies and medical purposes.

SECTION 3. LIMITED USE OF QUARANTINE PASS. The food and medicine pass (FM pass) or quarantine pass shall be used to buy food, medicines or go to hospital. A Home Quarantine Pass shall only allow one (1) person per household. FM or Q pass can only be used from the hours 5:00AM to 8:00PM and will strictly follow the SCHEME when to use during the ECQ:

F & M PASS CONTROL NO. with the last numbers:	CAN GO OUT THEIR HOME TO BUY FOOD AND MEDICINES EVERY:
1, 3, 5, 7, 9	Monday, Wednesday, Friday
2, 4, 6, 8, 0	Tuesday, Thursday, Saturday

NO FM or Q Pass will be allowed during SUNDAY. ALL business establishments will be closed **EXCEPT**: drugstores / pharmacies, hospitals / clinics and food establishments with home delivery services.

SECTION 3.SEPARABILITY CLAUSE. If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 4. REPEALING CLAUSE. All orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

SECTION 5. EFFECTIVITY. This order shall take effect immediately.
