REORGANIZATION OF MUNICIPAL SOLID WASTE MANAGEMENT BOARD

WHEREAS, health and environment problem requires utmost attention and cooperation among the concerned national government agencies, local government units, business community, civil society and the people in general;

WHEREAS, one of the basic functions and responsibility of the Local Government Unit is to provide basic services and facilities in the protection of the environment which include solid waste disposal system;

WHEREAS, Republic Act 9003 otherwise known as the Philippine Ecological Solid Waste Management Act of 2000 provides the creation of Municipal Solid Waste Management Board with the end view of generating greater multi- sectorial interest and partnership in addressing the garbage problem in the country.

NOWHEREFORE, I FRANCO M. CALIDA, Municipal Mayor of Hagonoy, Province of Davao Del Sur, do hereby order;

Section 1. Composition of the Municipal Solid Waste Management Board (MSWMB). The Municipal Solid Waste Management Board is hereby reorganized and to be constituted as follows:

- Chairman : Municipal Mayor
- Alternate Chairman : Sangguninang Bayan Member,
Chairperson, Committee on Environment
- Members : President, Liga ng mga Barangay
- President, Sangguninang Kabataan Municipal Federation (SK)
- Municipal Local Government Operations Officer (MLGOO)
- Municipal Planning and Development Coordinator (MPDC)
- Municipal Health officer (MHO)

Municipal Agriculturist (MA)

Philippine national Police (PNP)

Section 2. Duties and Functions:

- a) Monitor the implementation of the 10 year Solid Waste Management Plan and ensure the integration of various solid waste management plans and strategies of component barangays.
- b) Adopt specific revenue-generating measures to promote and ensure the viability of the solid waste management plans.
- c) Adopt measures to promote and ensure the viability and effective implementation of Solid Waste Management Programs;
- d) Recommend measures and safeguards against pollution and for the preservation of natural resources and its ecosystem;
- e) Coordinate efforts of the barangays in the implementation of SWM Plan;
- f) Convene regular meetings for purposes of planning and coordinating with the barangay for the implementation of SWM plans and programs;

Section 3. Secretariat. There shall be a secretariat to provide support to the board in the documentation relative to the implementation of the programs.

Section 4. Budgetary Support. The program/ project and activities of the board shall be funded from the 20% Local Government Development Fund (LGDF) - Solid Waste Management Program.

Section 5. Repealing Clause. All previous order inconsistent herewith is hereby repealed accordingly.

Effectivity. This order shall take effect immediately.
