EXECUTIVE ORDER NO. 24 - A

AMENDMENTS AND ADDENDUM TO EXECUTIVE ORDER NO. 24, SERIES OF 2020: AN ORDER DECLARING THE ENTIRE MUNICIPALITY UNDER GENERAL COMMUNITY QUARANTINE AND PROVIDING RULES AND REGULATIONS TO BE OBSERVED BY ALL THE TWENTY-ONE (21) BARANGAYS UNDER ITS SUPERVISION

AMENDMENT TO SECTION 18 :

18. The operation of mass/public transportation shall be allowed provided that only a reduced passenger capacity of fifty percent (50%) shall be permitted. All forms of mass public transport shall observed social/physical distancing. Those who do not wear face mask shall be denied service of any public transport.

18.1 Pedicabs / trimotors shall carry three (3) passengers only per trip.

18.2 All private (4-wheeled) vehicles shall carry three (3) passengers. Bigger 4-wheeled vehicles(Fortuner, SUV, Pajero, Vans, etc.) can carry more passengers whichever number is applicable but must likewise observe social distancing.

18.3 Single motorcycle vehicles are hereby ordered to follow "one back ride" policy and both must wear helmets and masks. The said travel shall only be for purposes of buying food and medicines. Joyride or non-essential travel is vehemently prohibited and shall be dealt accordingly.

AMENDMENT TO SECTION 28 :

28. All returning OFWs, regardless of origin, shall undergo Local Quarantine Protocol provided by the LGU.

28.1 All residents of Hagonoy who are coming back to this municipality from Davao City or from other places who have confirmed / positive COVID -19 cases shall also undergo Local Quarantine provided by the LGU.

ADDENDUM:

GOVERNMENT EMPLOYEES AND NON-DISRUPTION OF GOVERNMENT WORK

38. Government offices will continue to operate provided that they can follow the policy of social distancing among employees. For those offices who cannot possibly implement the social distancing, they can adopt alternative work arrangement : work from home and directed to identify their skeletal workforces.

Working tables must be arranged to strictly observe social distancing.

Proper Hand Washing. Frequent hand washing using clean water and soap for at least 20 seconds should be practiced. In the absence of the water and soap, using of hand sanitizer and 70% rubbing alcohol is advised.

HAGONOY PUBLIC MARKET MOVEMENTS

39. "Taboan Day every Saturday of Hagonoy Public Market at Barangay Lapulabao shall be allowed.

Provided that everyone is mandated to wear facemasks; Vendors are encouraged to wear hand gloves and face shield.

Footbath / disinfectants must be provided in the entrance / exit of the market
The wet sections must have an entrance, exit and one-way direction for people to go through. People cannot turn around and go back and cannot roam around the wet section.

Ambulant food vendors who are engaged in food and non- food commodities (essential items) EXCEPT "Ukay – ukay" (used clothes) shall be allowed to enter in their designated area within the market.

This Executive Order shall take effect immediately upon signing.
