AMENDMENT TO SECTION 2.2.1:

2.2.1 Contact Tracing Team (CTT) whose responsibility is to conduct contact tracing for all persons with known exposure to a COVID-19 patient to ensure that they are strictly observing the home-quarantine measures and monitor status of probable, suspected, and confirmed cases including family members with known contact to a confirmed case to mitigate possibility of contagion, and report daily update to the COVID-19 Provincial Task Force:
