CREATING THE MUNICIPAL CULTURE AND THE ARTS COUNCIL

WHEREAS, the Department of the Interior and Local Government (DILG) Memorandum Circular 2017-133 dated September 29, 2017 titled "Revision of DILG Memorandum Circular No. 2002-81, titled, "Creation of Local Culture and the Arts Councils."

WHEREAS, consistent above-stated purpose is the protection, preservation, and promotion of cultural heritage and the ethnicity of local communities. In line with this, the DILG-OSEC special provisions under Republic Act No. 1094 or the General Appropriations Act of 2017 mandated DILG to ensure the establishment of the local council. To strengthen the LGU as a cultural institution, its obligations prescribed in the National Cultural Heritage Act of 1009 are hereby rationalized as one of the functions of the Local Culture and Arts Council;

WHEREAS, the purpose of the Memorandum Circular is to enjoin all provinces, cities and municipalities to establish of a Local Culture and the Arts Council, implement related projects and/or strengthen existing ones thereafter;

NOW THEREFORE, I FRANCO MAGNO CALIDA, Municipal Mayor of Hagonoy, Davao del Sur, by virtue of the powers vested in me by law, do hereby order the reconstitution of the Municipal Culture and the Arts Council of Hagonoy, Davao del Sur, to wit:

SECTION 1. COMPOSITION. The Municipal Culture and the Arts Council shall be composed of the following:

SECTION 2. DUTIES AND FUNCTIONS OF THE COUNCIL:

As per DILG Memorandum Circular No. 2002-81 of the Creation of the Local Culture and the Arts Council:

1. Prepare an annual plan on culture, arts, and culture heritage in consonant with the Philippine Development Plan for Culture and the Arts, to be integrated in the local development plan considered in the annual appropriation ordinances;
2. Formulate programs and recommendations to develop and sustain local cultural and artistic talents, cultural industries, traditional and contemporary arts and crafts, and their processes;
3. Coordinate with the appropriate affiliated cultural agencies of the National Commission for the Culture and the Arts (NCCA) for the conservation and monitoring of national culture properties found in the LGU;
4. Conduct cultural events such as cultural festivals, competition, lectures seminars and symposia;
5. Identify such other programs and activities for the promotion of local cultural heritage and arts;

As per Republic Act No. 10066 of the National Cultural Heritage Act of 2009:

6. Ensure the protection, preservation, conservation and promotion of the local cultural and historical heritage;
7. Declare and maintain Local Heritage Zones;
8. Establish a Local Registry of Cultural Property;

As per Republic Act No. 7355 of the Gawad ng Manlilikha ng Bayan Act:

9. Acknowledge the importance of traditional folk artist as singular conduit between skills of the past and the future;
10. Revitalize a community artistic tradition thereby protecting a valuable fact of Philippine culture;

11. Provide mechanisms for identification and assistance for qualified traditional folk artists to transfer their skills to the community; and
12. Create opportunities for popularizing their works locally.

SECTION 3. MEETINGS. The Municipal Culture and Arts Council shall meet once in every quarter or as often as necessary upon call of the Chairperson or the Co-chairperson.

SECTION 4. EFFECTIVITY: This Executive Order shall take effect immediately.
