AN ORDER ESTABLISHING THE ADDITIONAL GUIDELINES FOR PARTICIPATING / INTERESTED BIDDERS IN THE STREAMLINED PROCUREMENT PROCESS OF INFRASTRUCTURE PROJECTS, GOODS AND CONSULTING SERVICES TO BE COMPETITIVE AND TRANSPARENT IN ALL MODES OF PROCUREMENT, IN THE MUNICIPALITY OF HAGONOY, DAVAO DEL SUR

WHEREAS, Executive Order No. 40, series of 2020 dated September 9, 2020, reorganized the Bids and Awards Committee (BAC) pursuant to the Government Procurement Reform Act (RA 9184);

WHEREAS, the existing BAC conducted the necessary milestones of procurement activities per standards set by the R.A. 9184 and its Implementing Rules and Regulations;

WHEREAS, there is a necessity to streamline the required documents for all those interested bidders to participate in all modes of bidding;

WHEREAS, manufacturers, suppliers, distributors, contractors and/or consultants to participate in the public bidding shall submit all the eligibility requirements which shall include a PHILGEPS Platinum Registration Certificate and updated Tax Clearance among others ;

NOW, THEREFORE, I, FRANCO MAGNO CALIDA, Municipal Mayor of Hagonoy, Davao del Sur, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. ELIGIBILITY DOCUMENTS.


