**REORGANIZING THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL  
(MDRRMC)  
OF THE MUNICIPALITY OF HAGONUY, DAVAO DEL SUR  
Amending Executive Order No. 05 Series of 2019**

**WHEREAS**, Republic Act 10121, known as “An Act Strengthening the Philippine Disaster Risk Reduction and Management System” providing for the National Disaster Risk Reduction and Management Framework and Institutionalizing the National Disaster Risk Reduction and Management Plan, appropriating funds therefore and for other purpose;

**WHEREAS**, this Act mandates the Local Government Units to provide and create the Municipal Disaster Risk Reduction and Management Council (MDRRMC) to exercise its powers and functions as stipulated in Section 2 of this Executive Order;

**WHEREAS**, participation and involvement of all sectors and stakeholders at all levels, especially the local community, Civil Society Organizations (CSOs), the private sectors and volunteers be institutionalized to adopt a disaster risk reduction and management approach that is holistic, comprehensive, integrated and proactive in lessening the socioeconomic and environmental impacts of disaster including climate change adaptation:

**NOW, THEREFORE, I, FRANCO MAGNO CALIDA**, Municipal Mayor of Hagonoy, Davao del Sur, by virtue of the powers vested in me, do hereby order the reorganization of the Municipal Disaster Risk Reduction and Management Council (MDRRMC) of this municipality:

**SECTION 2. FUNCTIONS.** The Municipal Disaster Risk Reduction and Management Council (MDRRMC) shall have the following functions:

1. Approve, monitor and evaluate the implementation of the LDRRMP's and annually review, test and develop the plan consistent with other national and local planning programs;
2. Ensure the integration of disaster risk reduction and climate change adaption into local development plans, programs and budget as a strategy in sustainable development and poverty reduction.
3. Recommend the implementation of forced, preemptive evacuation of local residents if necessary; and
4. Convene the local council as provided by the Act and its Implementing Rules and Regulations;

**Section 3. MEETING AND QUORUM:** The MDRRMC shall conduct a quarterly meetings on dates and place to be determined by the Body. The Chairperson shall call for a special meeting as he may deem necessary, and shall promulgate their respective internal rules for their meetings. The Municipal Disaster Risk Reduction and Management Office (MDRRMO) shall serve as the Secretariat of the Council. Presence of "50% plus one" of the members shall constitute a quorum.

**SECTION 4. EFFECTIVITY.** This Executive Order shall take effect immediately this **17<sup>th</sup> day of December 2020** at Hagonoy, Davao del Sur, Philippines.
